### What's NOT Happening in 2017

- Delayed the implementation of the AJCC Staging Manual 8th Edition to 2018, thus there will not be a NAACCR Standards for Cancer Registries, Volume II, Data Standards and Data Dictionary, Version 17.
- The NAACCR Guidelines for ICD-O-3 Update Implementation (published December 2013) included a table of new ICD-O-3 codes and terms effective for 2015; however, the use of the new codes was postponed due to issues with adding these codes to the CSv2 software. For diagnosis year 2017, all standard setters have **agreed to postpone these codes once again**, and to use the alternate codes published in Table 2 of the NAACCR Guidelines for ICD-O-3 Update Implementation.

### What's Staying the Same in 2017

- There are no reportability changes in 2017.
- Registries will continue to use the 2007 MP/H rules for cases diagnosed in 2017.
- Beginning with cases diagnosed January 1, 2017 and forward, the CoC will continue using the record layout and data collection requirements as published in NAACCR Standards Volume II, Version 16. There are no changes to CoC reporting requirements for 2017.
- Beginning with cases diagnosed January 1, 2017 and forward, CDC-NPCR will continue using the record layout and data collection requirements as published in NAACCR Standards Volume II, Version 16. There are no changes to CDC reporting requirements for 2017.

### What's NEW in 2017

- Reportability of NIFTP (noninvasive follicular thyroid neoplasm with papillary-like nuclear features) as a New Term for EFVPTC (encapsulated follicular variant of papillary thyroid carcinoma). The standard setters have agreed to collect NIFTP as ICD-O-3 morphology code 8343/2. The standard setters have agreed to collect EFVPTC specified as invasive or NOS as 8343/3 (papillary carcinoma, encapsulated) beginning with cases diagnosed in 2017.
- The Version 16D metafile was released in February 2017.
- Small updates will be released via FORDS: Revised for 2017:
  - 1. The allowable values listed in the header for Sex [#220] were corrected to 1-6, 9 to reflect the addition of codes 5 and 6 in 2015. 2.
  - 2. For Mets at DX—Other [#1117] the following code has been added: 2 Generalized metastases such as carcinomatosis.
  - 3. Minor coding clarifications were made to Tumor Size Summary [#756].
  - 4. Pagination was corrected for the First Course of Treatment section of the manual.
  - 5. The coding clarification in APPENDIX B: Site-Specific Surgery Codes for SKIN was updated to state "1 cm or more".

**<u>FCRA Public Relations/Editor</u> Janet Vogel, CTR** Blank vs X, the Saga Continues...

I have been working in the registry field since before the birth of my oldest child who is now twentyone, so I'm not exactly a new registrar anymore, but somedays, I still feel like it. During this past year, I've totally regressed to my earlier days of registry work, which to be honest has not been a bad thing. I am no longer confident in my knowledge of staging, and question everything I know or think I know about the subject, just like I did when I was but a wee "baby" registrar. I have every single reference open on both my computer and hard copies strung out all over my office. I gently page through my copy of the 7<sup>th</sup> Edition of the AJCC manual, it is tattered and torn, full of notes. reprinted pages, and sticky notes galore, to be honest it barely resembles a book anymore, it's in several pieces held together with a rubber band, but still I lug it out every day and refer to it. This is probably the best thing that I could have done to improve my skills as a registrar. All too often we tend to rely on our memories,



or drop downs in our software to abstract our cases, even though we've been taught and warned never to do that very thing. Still the more confident we get with our skills, bad habits form, and sometimes are hard to break, but I feel broken right now, so I'm changing my ways, and going back to basics, with my book in hand! I have had the opportunity to work with some fabulous registrars over the years, and I know I am not alone in how I've been

#### **NEW REQUIREMENT FOR CTR'S:**

Credentialed individuals are required to comply with a new continuing education standard as set forth by NCRA's Council on Certification. At least four (4) of the required 20 CE hours must fall within "Category A" which covers the specific topic(s) of: directly assigned stage and/or site specific coding principles. feeling about staging either this year, we are all kind of confused, and unfortunately, I also have the data to prove it, albeit a small sample. I worked with some registrars and we pulled lists of cases diagnosed in 2016, and transferred the AJCC TNM & Group Staging Fields and Cancer Directed Surgery Codes to excel to evaluate areas of potential misunderstanding.

Once the data was in Excel, using Filters, I set up different scenarios to look for potential coding issues. This gets a little tricky because of the X vs Blank rules, and sometimes it's hard to differentiate if the Blank value is correct or if the abstractor just forgot to code it, or if the X is valid or not, it's still a bit murky to me, but below is a list of scenarios I evaluated and rationale behind why I chose to review these cases. Keep in mind some of the scenarios below will not yield an "edit" but the coding is either outright wrong or at the very least questionable and worthy of review.

What I found after reviewing several registries data; is over 30% of the cases evaluated had very questionable staging coded, so there is an opportunity for learning and growth in this area of abstracting. One of the biggest areas of confusion still seems to be when to code an X versus a Blank, so much time an energy has been spent trying to teach and learn this topic, but alas it still seems to escape many a registrar, so we need to continue to be diligent with our pursuit of knowledge on this topic.

Qualified candidates must meet the following requirements: CTR (Certified Tumor Registrar) preferred, Bachelor's degree in Health Information Management (HIM), Business, Healthcare Administration or a closely related field; or completion of the American Health Information Management Association's (AHIMA) Independent Study program, or an approved Medical Transcription or Coding Program or two years of college courses in Health Information Management. Registered Health Information Administrator (RHIA) Registered Health Information Technologist (RHIT), Certified Coding Specialist (CCS) by the American Health Information Management Association or Certified Medical Transcriptionist (CMT) by the American Healthcare Documentation Integrity Association (AHDI) or Certified Professional Coder (CPC) by the American Association of Professional Coders is required – renewed every two years. One (1) years of management/leadership experience is required. Experience in management of a cancer registry is recommended.





### II. MEMBERSHIP


- 1. All applications for membership shall be submitted in writing to the Chair of the Membership Committee.
