## TRIBUTE TO MARTHA OLIVA, RHIT, CTR April 25, 1931 - June 11, 2019 Written by: Sally Kruse, CTR



Prior to coming to the United States, Martha obtained a degree in Graphic Design (Asturias, Spain), Major: BA, Minor: Statistics, and was a Certified Public Accountant (Havana, Cuba). She was the Head Accountant, Compañia Nacional de Morteros, S.A. (concrete for construction) February 1959 to February 1960. The Head Accountant, Hospital Division, National Health and Welfare Ministry February 1960 to June 1960. This was followed by the Office General Manager, Hospital Division, National Health and Welfare Ministry July 1960 to September 1962. Director of Medical Records Department and Statistics, University of Havana, School of Medicine "Calixto Garcia" Teaching Hospital from

October 1, 1962 to October 31, 1965. After that she had to abstain from any kind of public activity from November 1, 1965 to December 9, 1971, due to political reasons.

Historically, cancer registrars have overcome adversity to achieve respect and recognition, but nothing like what she went through. Martha had a child who had leukemia and passed away (notice her career changed from accounting to the medical field – she wanted to find a cure). In her position as the Director of the Medical Records Department & Statistics, she began taking meticulous notes that turned into a teaching manual. The government had seized all of her property, including her personal belongings, plus her career and dignity were stripped. She had applied for and received permission to leave Cuba. It was then that Martha decided to send the manual to her relatives in Miami – it was seized and she was told that it was not allowed. Then, she decided to send a few pages at a time to her relatives (this was her life's work).

Martha boarded the plane and even had a seat. Then suddenly a couple of soldiers marched on and announced they needed two seats. They pointed to Martha and another woman and escorted them off of the plane. She suspected that they had opened her letters and considered her a spy.

She was arrested within a few weeks. While walking down the street, Martha was grabbed by two men and thrown into the back of a car. They placed her in in a one room, concrete, brightly painted pink, dungeon. The only light came from a crack under her cell door. She kept track of the days by scratching a line on the wall when she heard the soldiers march by her door. Occasionally, the door would swing open and a man with a water hose would spray her and wash out the room (there were no facilities – even the board to sleep on was slanted). It was two weeks before her parents found out that she was a prisoner and she was able to leave solitary confinement.

Martha told me then, she was one of the lucky ones – her prison job was in the kitchen cleaning pots (lots to eat) – they were so big and she was little – that the others would



hold on to her feet as she scrubbed them. They attempted to brain wash her and her only crime was rejecting Communism.

Martha finally gained her freedom in January of 1972 and was allowed to come to the United States. She kissed the ground in Miami, knowing she was finally free to speak, learn, and be an individual. Something we have all taken for granted.

Martha's first job in the USA was the Supervisor of the Accounting Department, Chem Lab Corp. (Lederle Laboratories) from January 17, 1972 to March 31, 1974. Because of her previous hospital experience, she was hired as Supervisor, Medical Records Department, Jackson Memorial Hospital Miami, Florida April 1, 1974 to January 12, 1976. But she wasn't satisfied until she could communicate in the language of her new country. She learned English by watching TV and became proficient in her new tongue. It didn't take long and Martha obtained Accredited Record Technician (RHIT) in April 1978 and her CTR on the very first test in 1983. She didn't stop there; she became the coordinator of the cancer program at Jackson Memorial Hospital and volunteered her time at the League against Cancer in Miami. When I say volunteer, I don't mean a couple of hours a week, she was there every night.

She was eternally grateful to her new country and profession. She was the treasurer of the National Cancer Registrars Association (NCRA). She not only gave her time, but also helped out financially and she did the same for the Florida Cancer Registrars Association (FCRA). She was the Distinguished Member of NCRA and FCRA (Founding Member) and served as President to both Associations. She believed in giving back what she received and she has given so much.

Martha provided leadership to FCRA in her roles as President Elect, President, and Immediate Past President, Treasurer. In addition to the elected positions, she has served as chair of multiple committees and received the NCRA Distinguished Member award in 2002 and FCRA Distinguished Member in 2017. Martha was instrumental in acquiring the "501(c)(3)" approved by the Internal Revenue Service as a tax-exempt for the FCRA Foundation and has been Treasurer of the Foundation since its inception in 2010. She served in this position with involvement one week prior to her death.

She used her many talents to translate to Spanish - The Professional Review Course for Tumor Registrars: Principles of Oncology, Cancer Program Organization and Management, Biostatistics and ICD-O Spanish for the Medical Science Campus, University of Puerto Rico, San Juan, Puerto Rico in September 1993. Her many achievements and honors are innumerable. She was a friend to everyone she's ever met and is best described as compassionate, loyal, strong, and smart with a heart of gold. Martha will never be forgotten and her legacy will live on – she will be dearly missed and forever in our hearts.



## BY-LAWS CHAIR Mayra Espino, BA, RHIT, CTR mbectr@gmail.com



Welcome summer! Most of you know how much I enjoy summer; a fun time to take a walk, especially on any beach. For many years I have enjoyed serving as your Bylaws Chairman, which consists of interpreting and communicating the FCRA bylaws to you and giving them attention when needed. It is important to be ready for change and expect it with a positive welcome!

The FCRA Bylaws go through annual review and are shared amongst the FCRA board so important decisions can be made regarding updates and revisions to areas that may be outdated. After further review of the current bylaws, there was one area in particular

which was in need of being updated, the *FCRA/FCDS Liaison* position. The position was first initiated, many years ago, where the concept was tied to other positions covered by FCRA in C-Crab. These positions have since become obsolete and no longer a part of the cancer registry. Therefore, the *FCRA Liaison* was no longer involved as before or in need of an appointment by the Governor, as it is stated in the current bylaws. Discussion ensued regarding this position, which evolved into other revisions made by the board as it is evident to keep with current trends in the profession.

The Executive Board suggested the following changes be proposed to the 2016 Current FCRA Bylaws regarding the FCRA/FCDS Liaison Position:

Proposal Modification: CHANGE the (4) four year term to a (2) two year term.
Proposal Modification: CHANGE the verbiage in section V. STANDING COMMITTEES REMOVE "approved by the Florida State Office of the Governor."
Proposal: ADD "The FCDS Liaison will also function as the Co-Chair of the FCRA/FCDS Task Force along with a member from the FCDS."

These proposals will be discussed at the FCRA Business meeting which will be held on July 29, 2019 in Orlando. This position will not be associated with C-CRAB. The application for approval from the Governor has been eliminated. In addition, the position of the *FCRA/FCDS Liaison* will be a *Presidential* appointment. This position was established to have a communication channel between FCRA and FCDS through a liaison that represents FCRA. The intent of the position is to communicate effectively with open harmonious channels between each other. If any registrars would like to share ideas or thoughts with the FCRA/FCDS Liaison, they will be able to do so through the FCRA website once it is up and running.



## *Most importantly*, the "FCDS Liaison will also function as the co-chair of the *FCRA/FCDS Task Force* along with a member from the FCDS".

We expect to see you at the annual business meeting as these bylaws may be amended by two-third (2/3) vote of the voting members present. Voting is conducted at any business meeting of FCRA, provided that the amendments have been proposed by the Executive Board, Standing Committee, or an active member of FCRA in good standing. All proposed amendments will be submitted to the Bylaws Committee for review.

As your Bylaws Chairman, I will be responsible for ensuring that a copy of the proposed amendment has been submitted in writing and made available to every FCRA member, one month prior to the business meeting at which time it will be voted upon. Please watch for correspondence from the FCRA Executive Board and your Bylaws Chairman for information regarding proposed changes.

#### THE DOLORES KRULL MICHELS-HARPER, CTR MEMORIAL FUND

On November 25, 2018 in Instow, England, the Cancer Registry community lost one of its GREAT ONES Born Dolores Jean Krull in Pittsburgh, Pennsylvania on November 29, 1936 to Frank and Genevieve Krull, Dolores was the oldest of four siblings. She met her 1<sup>st</sup> husband. Bud Michels in High School and they married in 1957. They had three children: Susan (deceased in 1962). Jodi and Bud, Her husband passed away in 1983.

Dolores had a distinguished career as a CTR serving as Manager of the Division of Patient Registries at **Allegheny General Hospita**l in Pittsburgh, Pennsylvania. She was also an adjunct instructor in Registry Administration at the School of Health Related Professions at the University of Pittsburgh. Dolores was instrumental in getting NTRA's participation in evaluating the curriculum for this formal education program.

One of her most unique experiences was that, following the death of her 1st husband, in 1990, she moved to <u>Riyadh</u>, Saudi Arabia to become the Cancer Program Director **of King Faisal Hospital and Research Center**. It was here that she met her  $2^{nd}$  husband, Charlie Harper. They retired to Instow, England in 1997.

Before moving to Saudi Arabia, Dolores was active in many Cancer Registry Associations including NCRA (then NTRA) that awarded **the NTRA Distinguished Member** to her in 1992. Dolores was a founding member of the NTRA and served as President during 1981-1982. Dolores was also active in the Pennsylvania Tumor Registrars Association serving on many committees and as President (1975-76). She was also a Liaison to the American Joint Committee on Cancer (AJCC) and served on several committees and working groups for the ACoS COC. In addition, she was an active volunteer for her local American Cancer Society. Dolores' publications were numerous; many have appeared in the pages of The Connection and The Abstract.

Dolores was also a good friend to FCRA, choosing Orlando for the location of the annual NCRA conference in 1982 when she was NCRA President. She also participated as faculty for several FCRA Educational conferences and was chosen as an **Honorary FCRA Member** in 1989. To honor all of the contributions Dolores made to the education of cancer registrars throughout her career, the FCRA Education Foundation has created the DOLORES KRULL MICHELS - HARPER MEMORIAL FUND.

The FCRA Education Foundation was founded as a vehicle to build much needed funding to support education of Cancer Registrars to ensure that the quality of the cancer data collection and analysis will continuously improve through the education in Cancer Registry Management and its evolving practice.
